Sample Wording for Your Wills

The following wording for your will may be printed to share with your lawyer, or retain it for the right moment.

A general bequest designates a certain dollar amount of property, usually cash, to the charity you select.

Example: *"I give to the Royal Alexandra Hospital Foundation the sum of \$10,000.00 for its general purposes and greatest needs."*

A specific bequest directs that the Foundation is to receive a particular asset:

Example: *"I give to the Royal Alexandra Hospital Foundation 500 shares of XYZ stock for its general purposes and greatest needs."*

A residual bequest designates for the Foundation all, or a portion, of whatever remains after all debts, taxes, expenses and other bequests have been paid.

Example: *"I give to the Royal Alexandra Hospital Foundation fifty percent (50 percent) of the rest, residue and remainder of my estate for its general purposes and greatest needs."*

A contingent bequest takes effect only under certain conditions:

Example: *"In the event my wife does not survive me, I give to the Royal Alexandra Hospital Foundation the sum of.... for its general purposes and greatest needs."*
